II. VILLAGE/LOCAL LEVEL TASK FORCE ON RUIHHLO DO

Task Force to be formed in every Village/Locality as under: Members:

1. Members of Local Council/Village Council.

2. Members of elected YMA Branch OB/ MTP Branch OB at Siaha/ YLA Branch OB at Lawngtlai.

3. Representatives from all the Denominations of Local Churches.

4. Representative from MHIP/MCHP Siaha/LWA Lawngtlai.

5. Representative from MUP.

- Village/Local Level Task Force on Ruihhlo Do committee may appoint additional member if considered necessary.
- The Chairman, Vice-Chairman leh Member Secretary will be elect by the respective Village/Local level Task Force.

III: Terms of Reference (ToR) for the State, District and Village Level Task Forces on Supply, Demand and Harm Reduction in Mizoram:

A: SUPPLY REDUCTION:

State Level Core Committee on Ruihhlo Do:

- 1. Assess the requirement of equipments for drug/liquor detection and submit proposal for procurement of the same (i.e. logistic support)
- 2. The Task Force shall have half yearly meeting.

District Level Task Force on Ruihhlo Do:

- 1. Exchange of intelligence/information about trend of drugs trafficking.
- 2. Monitoring of illicit cultivation of Cannabis or Poppy crops in the district.
- 3. Identification of drug traffickers, peddlers and users.
- 4. Identification of likely places for manufacture of alcohol.
- 5. Performance of joint duties/raids on illicit trafficking/possession of drugs & liquor.
- 6. Conducting awareness programmes about the provisions of NDPS Act, Liquor Laws and harmful effect of drug & liquor. Awareness on importance of Prosecution witnesses.
- 7. Creation of 24x7 info. desk.
- 8. Other issues as deem fit.

Village/Local Level Task Force on Ruihhlo Do:

- 1. Exchange of intelligence/information about trend of drugs trafficking.
- 2. Monitoring of illicit cultivation of Cannabis or Poppy crops in the District/Village areas.

3. Identification of drug traffickers, peddlers, users and liquor sellers.

4. Identification of likely places for manufacture of alcohol.

5. Performance of joint duties/raids on illicit trafficking/possession of drugs & liquor.

 Conducting awareness programmes about the provisions of NDPS Act, Liquor Laws and harmful effect of drug & liquor. Awareness on importance of Prosecution witnesses.

B. DEMAND REDUCTION:

State Level Core Committee on Ruihhlo Do:

1. Develop a State Level Strategy for Drug use, prevention, treatment and care.

 Implement activities like capacity building, meetings, development of IEC materials etc. for the district and village level task forces on drug demand reduction.

District Level Task Force on Ruihhlo Do:

 Train district and village level task force members and service providers on drug prevention and drug related harms and treatment services.

2. Generate awareness on drug prevention and drug related harms and treatment services through district level campaigns, workshops and trainings.

3. Facilitate setting up of drug treatment centres as required.

4. Provide for maintenance and upkeep of the drug treatment centres in the district.

5. Facilitate accreditation of drug treatment centres by setting up district level committees to fast-track the processes and help providing evidence based drug treatment services in remote locations.

6. Districts to facilitate the process of enlisting and updating evidence based quality drug treatment services and share it with the villages,

Village/Local Level Task Force on Ruihhlo Do:

- Conduct awareness on drug prevention and drug related harms and treatment services in the community through local campaigns at village events.
- 2. Identify people who use drugs and encourage them to seek drug treatment services from centres listed out by the StateCommittee.

3. Identification of drug traffickers, peddlers, users and liquor sellers.

4. Develop recovery groups with people who have received drug treatment services to support each other to remain drug free outside treatment centres and continue to be in touch with treatment processes.

C: HARM REDUCTION:

State Level Core Committee on Ruihhlo Do:

1. Coordinate Harm Reduction with service providers.

2. Strengthen the on-going HIV activities at the district and village level task forces on drug demand reduction.

District Level Task Force on Ruihhlo Do:

1. Coordinate with District AIDS Control Societies (DACS), Opioid Substitution Therapy(OST) Centres and HIV Programme Officers, IDU Targeted Interventions and HIV Link workers.

2. Generate Awareness on benefits of Harm Reduction Services, their uptake,

and continued linkages with service providers.

3. Support formation of District level Drug Users forums and Self Help Groups (SHG).

e.g. Alcoholics Anonymous and Narcotics Anonymous and their active engagement in the various aspects of Harm ReductionServices.

4. Coordinate with the DACS, OST, HIVPOs and Link workers to facilitate registration of IDUs with OST, NSP and other Harm Reduction Services.

Village/Local Level Task Force on Ruihhlo Do:

1. Coordinate with OST Centres, HIV Link workers.

2. Generate Awareness on benefits of Harm Reduction Services, their uptake, and continued linkages with service providers and reduction in drop-outs in the community through local campaigns at village events.

3. Engage with members of local drug users forum and SHGs to help in the

awareness, uptake and retention of Harm Reduction Services.

4. Ensure registration of IDUs with OST, NSP and other Harm Reduction Services and their retention in treatment by removing barriers.

5. Generate Awareness on Drug Overdose prevention, treatment and care in the community.
